# 2. GENERAL SAFETY RULES



# Warning

Never service damaged battery packs. Service of battery packs should only be performed by the manufacturer or authorized service providers.

### 2.1. INTENDED USAGE

- The PELLENC Power Tool battery Power Pack M, M+, L, L+ is designed to work with the Olivion or Power 48 shaker rake (SOLO or DUO heads).
- The PELLENC Power Tool battery Power Pack M, M+, L, L+ must be operated from the ground or from a suitable platform that is completely stable and safe.
- The PELLENC Power Tool battery Power Pack M, M+, L, L+ is intended for outdoor use only.
- Any other use of this tool is not intended.
- The company PELLENC accepts no responsibility for any damage caused by improper or unspecified use different from its original intention.
- The user is responsible for any accident resulting from improper use or unauthorized modification of this tool.
- The company PELLENC accepts no responsibility for any damage caused by the use of non-original parts or accessories.

## 2.2. SAFETY MEASURES ASSOCIATED WITH THE USE OF THE TOOL

#### 2.3. SAFETY MEASURES ASSOCIATED WITH BATTERY USE

- 1. If not using the battery unit, store it away from other metal objects such as paper clips, coins, keys, nails, screws or other such small metal items that might form a connection between the two terminals. Creating a short circuit between the battery terminals can result in burns or even a fire.
- Keep the battery out of the reach of children and place it on a non-combustible support.
- 3. Do not interfere with its cooling cycle.
- 4. Do not use or leave the battery near a heat source (> 60°C).
- 5. Do not leave the battery in direct, strong sunlight.
- 6. Do not expose the battery to microwaves or high pressure.
- 7. Do not immerse the battery in water.
- 8. The batteries must be charged in a dry, ventilated room at a temperature between 10°C and 25°C maximum, away from any moisture.
- 9. If the battery is not used for 10 days, the battery will automatically discharge until it reaches its storage charge rate, and then goes to sleep. The battery heats up during this phase.<sup>1</sup>.


- 10. Over time, the capacity of your battery decreases. When it reaches half of its original battery-life operating autonomy, it should be replaced.
- 11. The battery may lose 1 to 4 % of its capacity when exposed to a temperature higher than or equal to 55 °C for one week.
- 12. The charging location must be equipped with a class D fire extinguisher (for metal fire) in good working order.
- 13. The standards in effect must be complied with when either shipping a complete tool or a battery.
  - Complete tool with battery: product classified UN3481 class 9.
  - Battery alone: product that is classified as class 9, UN3480.
- 14. Use of a battery other than that provided by Pellenc SA is dangerous (risk of serious injury). If a different battery is used, Pellenc SA cannot be held responsible for any consequences.
- 15. The battery must be protected from any impact and must be positioned and secured appropriately during transportation.
- 16. In the case of suspicious smoke, place the battery outside the charging area or transportation vehicle as far away as possible from any inflammable material.
- 17. Never store a battery when its capacity is below 50 %. Recharge the battery before storage if the value is below 50%.
- 18. Under inappropriate conditions, liquid may leak from the batteries; avoid contact. In the event of accidental contact, rinse with water. In the event of contact with eyes, seek professional medical help. The liquid leaking from the batteries can cause irritations or burns.
- 19. Pellenc power tools must only be used with the battery units designed for the purpose. Use of other battery units can present a risk of injury and fire.
- 20. Recharge only with the charger specified by the manufacturer. A charger suitable for one type of battery pack may present a risk of fire if used with another type of battery pack.
- 21. Do not use the battery for any purpose other than that initially envisaged (exclusively for use with Pellenc tools).
- 22. At the end of its life, the battery must be returned to the authorized distributor from whom it was purchased to be recycled in accordance with waste regulations.
- 23. Fragile case, contains an electronic board and lithium.

#### 2.4. SAFETY MEASURES WHEN USING THE "PELLENC" CHARGER

- 1. When in operation, the charger's temperature can reach 60°C. No flammable material must be within 1.5 metres of the charger and battery.
- 2. Place the charger out of children's reach and onto a non-combustible support.
- Do not interfere with its cooling cycle.
- 4. The charger is intended only for recharging the battery. Do not charge non-rechargeable batteries.
- 5. The charging location must be equipped with a class D fire extinguisher (for metal fire) in good working order.
- 6. If the outlet cord is cut or damaged, the complete charger must be returned to the authorized distributor from which the tool was purchased in order to avoid any danger.
- 7. Only recharge using the "PELLENC" charger indicated by the manufacturer. A charger suitable for one type of battery pack may present a risk of fire if used with another type of battery pack.
- 8. This charger is designed to charge Pellenc tool lithium batteries.
- 9. Do not use it for any other purposes.
- 10. Children must be supervised to ensure they do not play with the charger.
- 11. Check that the cable cannot be bent and that it does not touch hot surfaces or sharp edges.
- 12. Ensure good ventilation during the charging.
- 13. Never cover the charger. This charger must not be used outdoors.
- 14. Make sure the power connector is not exposed to water.
- 15. Never attempt to charge a damaged battery.
- 16. The grid connection must comply with national electrical regulations.
- 17. Check the wiring of the charger before use. Never use the charger if the cable is damaged
- 18. When the battery is charging, place the charger on a non-flammable support, more than 1.5 m away from any flammable object.







#### 4.2. CHARGING THE BATTERY


### **Note**

When the battery is discharged, the tool stops automatically; the gauge display shows 00 and the buzzer beeps intermittently.


See 7.2. Summary of charge indicator and beep messages, page 26.

Before using the battery for the first time in the season, perform a full charge (99% fixed).

1. Check that the battery switch (1) is in the "0" off position.



- 2. Install the charger and battery in a ventilated, dry place, away from dust.
  - Temperature between 10°C and 25°C.
- 3. Place the battery in a stable position.



# Caution



Before connecting the charger to the mains, check that your power system characteristics comply with the specifications given on the charger.

See 3.3. Technical characteristics - Charger, page 11.

- 4. Connect the charger plug (2) to the mains. The charger LED (3) lights up red.
- 5. Remove the charge connector cap (4).
- 6. Connect the charging cord (5) to the battery charging connector

The battery beeps twice when it recognises the charger.

The CB5022HV charger indicator light will turn flashing green after a few seconds.



Charging is complete when the message 99 appears steady on the gauge display.


The charger indicator LED (3) will flash green to indicate that the battery is being charged.


It flashes while charging, and shows steady when the charging is completed.


- 7. Once the battery is charged, disconnect the charging cord (5) from the battery.
- 8. Then disconnect the mains plug from the charger (2).


#### **Note**

After a long period of storage (new battery, wintering, etc.) when the charger is disconnected, the gauge display may show a value of less than 99%. This is a normal phenomenon which can reoccur for up to 5 charge cycles with normal use between each charge.














#### 4.3. BATTERY DISPLAY


# The battery has a gauge display showing the remaining capacity it holds. The capacity is expressed as a percentage.

- If the gauge display shows 99, the battery is fully charged.
- If the gauge display indicates a value greater than 55 after one day's work, it is not necessary to recharge the battery for a second day's work.
- If the gauge display shows 00 or a value close to it, you must recharge immediately.

# Caution




The adjustment of the harness ensures the working comfort of the user of the Power Pack M, M +, L, L+. It must be adjusted before each use of the tool.

To protect your back, take the time to adjust your harness properly.

The harness adjustment steps below allow the user to find their own comfort point. This is why the harness adjustment is personal and specific to each user of the tool.

Once the tool is connected to the battery, the tool's power cord should be fitted to the carrying harness.

There are two possible solutions, and the operator is free to choose one or the other according to his working preferences.



- 3. Close the two Velcro fasteners.










# Method 2: fitting the power cord on the bottom of the carrying harness


- 1. Open the Velcro fastening on the chest strap of the harness.

- 3. Close the Velcro fastening on the chest strap of the harness.



# Adjustment of the harness

- Slip the harness over your back.
   The adjustment straps must be relaxed so as not to interfere with the user's adjustment.
- 2. Close the waist strap of the harness at hip level.
- 3. Pull on the chest strap to adjust the position of the belt.

  The belt should be positioned above the buttocks and the user should feel well supported.
- 4. Fasten the chest strap.
- 5. Pull on the chest strap to adjust the position of the harness.


  This strap stabilises the weight of the battery on the user's back.

#### 7.3. BATTERY REPLACEMENT

# **Important**

The battery must be replaced only by an approved distributor.

### 8. STORAGE AND TRANSPORT

#### 8.1. BATTERY STORAGE CONDITIONS

- Store the battery unit and its charging device in a place away from any heat, dust or dampness, and ensure that the switch is on the "0" off position.
- Never store the battery in an ambient temperature of more than +45 °C.
- In order to conserve a long battery life and prevent deterioration, the battery must be charged when stored and recharged every 24 months if it is not used.
- · Do not operate the switch while in storage.
- To ensure long battery life, the battery should be stored in a dry and warm place between 0 °C and 25 °C.
- · No combustible object must be placed within 1.5 metres of the battery.
- · The charger is maintenance-free.
- If the battery is not used for 10 days, the battery will automatically discharge until it reaches its storage charge rate, and then goes to sleep. Warming up occurs during this phase.

### 8.2. TRANSPORT



#### Caution

Never transport a battery with a capacity of more than 30% by means of a postal carrier.

## **Important**

Never carry the tool or the battery by the power cord.

## 10. WARRANTIES

#### 10.1. GENERAL WARRANTIES

#### **10.1.1. STATUTORY WARRANTY**

#### 10.1.1.1. LATENT DEFECTS WARRANTY

Apart from the commercial warranty provided for under Article II, Article 1641 of the French Civil Code states that "the seller is bound to a warranty on account of latent defects of the object sold which render it unfit for the use for which it was intended, or which would impair said use to the extent that the buyer would not have acquired it, or would only have paid a lesser price for it, had he/she known of them".

Article 1648 of the French Civil Code "The action resulting from latent defects must be brought by the purchaser within two years after the discovery of the defect."

### 10.1.1.2. LEGAL GUARANTEE OF CONFORMITY

Article L.217-4 of the French Consumer Code "The seller delivers goods in compliance with the contract and is liable for defects of conformity existing upon delivery.

The seller is also liable for any lack of conformity resulting from the packaging, assembly or installation instructions whenever its contractual liability is engaged in this regard or the latter are carried out under its responsibility.

Article L.217-5 of the French Consumer Code "Goods are compliant with the contract":

- 1. If they are fit for the purpose normally expected of similar goods and, where applicable:
  - If they correspond to the description given by the seller and possess the qualities that were presented to the buyer in the form of a sample or model;
  - If they possess the qualities that a buyer can reasonably expect given the public statements made by the seller, the producer or its representative, especially in advertising or labelling;
- 2. Or if it has the characteristics defined by mutual agreement between the parties or be suitable for any special use sought by the buyer, brought to the attention of the seller and accepted by the latter.

Article L.217-12 of the French Consumer Code "legal action resulting from lack of conformity lapses two years after delivery of the goods".

#### 10.1.2. PELLENC COMMERCIAL WARRANTY

#### 10.1.2.1. CONTENTS

#### 10.1.2.1.1. GENERAL INFORMATION

In addition to legal warranties, client users benefit from the commercial warranty on PELLENC products covering the exchange and replacement of parts recognised as being out of order, due to machining defects, assembly defects or material defects, whatever the cause.

The warranty forms an inseparable whole with the product sold by PELLENC.

#### 10.1.2.1.2. SPARE PARTS

The commercial warranty also covers PELLENC original spare parts, excluding labour and to the exclusion of certain parts of each product provided at delivery.

#### 10.1.2.2. DURATION OF WARRANTY

#### 10.1.2.2.1. GENERAL INFORMATION

PELLENC products are guaranteed under the commercial warranty as from delivery to the customer for a period of two (2) years for products connected to a PELLENC battery, and for a period of one (1) year for other PELLENC products.

#### 10.1.2.2.2. SPARE PARTS

PELLENC replacement parts replaced under the product warranty are guaranteed under the commercial warranty as from delivery of the PELLENC product to the customer user for a period of two (2) years for products connected to a PELLENC battery, and for a period of one (1) year for other PELLENC products.

In the case of products connected to a PELLENC battery, parts that are replaced under the product warranty after the 12th month of use, are covered for a period of one (1) year.

#### 10.1.2.2.3. WARRANTY EXCLUSIONS

Products that have been subject to abnormal use, or that have been used under conditions and for purposes other than those for which they were manufactured, are excluded from the commercial warranty, especially in the case of non-compliance with the conditions stipulated in this user manual.

Nor does it apply in the event of impact, dropping, negligence, lack of supervision or maintenance or if the product has been transformed. Products that have been altered, transformed or modified by the user customer are also excluded from the warranty.

Wear parts and/or consumables are not covered by the warranty.

#### 10.1.2.3. IMPLEMENTATION OF THE COMMERCIAL WARRANTY

#### 10.1.2.3.1. PRODUCT COMMISSIONING AND COMMISSIONING DECLARATION

No later than eight days after delivery of the goods to the user customer, the DISTRIBUTOR undertakes to complete the computerised commissioning declaration form in order to activate the latter on the website www.pellenc.com,

under the heading "Extranet Access" in the "Pellenc Extranet Service" menu, using the identifier previously issued by PELLENC.

Failing that, commissioning declaration will not be effective and implementation of the PELLENC commercial warranty will not occur. As a consequence thereof, the DISTRIBUTOR must ensure the financial burden of its intervention under the warranty without being able to pass on the cost to the client user.

The DISTRIBUTOR also undertakes to complete the warranty card or the certificate of warranty and commissioning for self-propelled equipment provided with the product after having the user customer sign and date it.

#### 10.1.3. PAID AFTER-SALES SERVICE

#### 10.1.3.1. GENERAL INFORMATION

Malfunctions, breakdowns, breakages resulting from misuse, negligence or improper maintenance by the user customer, as well as malfunctions resulting from the normal wear of the product, are subject to the payment of the after-sales service, even during the period of the legal and commercial warranty. After-sales service repairs that fall outside of the legal and commercial warranty also include maintenance, adjustments, diagnostics of all types, and cleaning, without the present list being exhaustive.

#### 10.1.3.2. WEAR PARTS AND CONSUMABLES

Wear parts and consumables also fall within the after-sales service.

#### 10.1.3.3. SPARE PARTS

Paid after-sales service also covers PELLENC original spare parts, excluding labour and outside the legal and commercial warranty period.

In case of replacement of original PELLENC spare parts in the context of after-sales service, said latter are covered by a warranty of one year as from the installation date.
